A pop-up show is an opportunity for an artist to be featured and sell in the Feature Foyer Gallery. We want this solo show to have work that is under \$100. Fine art and Fine Craft will be considered.

**Important Dates**

- Deadline to Enter: .....December 6<sup>th</sup>, 2018
- Exhibition Dates: ..... January 11<sup>th</sup>, 2019 - February 23<sup>rd</sup>, 2019
- Artist Notification: .....December 8<sup>th</sup>, 2018
- Shipping deadline of work to Blue Line Arts: ..... January 5<sup>th</sup>, 3pm
- Hand deliver work to Blue Line Arts: .....January 6<sup>th</sup> & 7<sup>th</sup> from 10am to 3pm
- Opening Reception: .....January 19<sup>th</sup>, 2019 5pm to 8:30pm
- Closing Reception: ..... February 16<sup>th</sup>, 2019 5pm to 8:30pm
- Pick up unsold work from Blue Line Arts: .....0... February 24<sup>th</sup> or 25<sup>th</sup> 10am to 3pm

## Eligibility

- This call is open to all artists.
- All artwork must be original and completed within the last two years.
- Artists will be responsible for managing their own inventory throughout the show.
- All 2-D works must be ready to hang.
- All artwork must be for sale. Priority will be given to applicants who include a range of items priced at less than \$100.
- The pop-up shop should have an overall cohesive look; may include wall hanging pieces, prints, jewelry, small mixed media and other various craft mediums.
- Application should include proposed pop up inventory, price range details and pictures of the craft items representative of the available work.
- Any artwork that differs significantly from the images provided may be disqualified.
- No accepted entry may be withdrawn or sold outside of the exhibition prior to the closing date.
- Blue Line Arts handles all sales transactions. Non-members receive a 50% commission from all gallery sales and Artist level members receive a 60% commission.
- The artist is responsible to pay for all shipping and should provide a prepaid label from FedEx or UPS (Not USPS) for return of artwork.
  
- Applicants must apply online using the application form below. There is a \$35 fee for non-members, Artist level members may apply free of charge.

**Application Requirements:** Applicants must apply using the form on the Blue Line Arts website, <http://www.bluelinearts.org/call-to-artists>. You must be 18 years or older to apply.
