Artist Agrees

- To submit an application at least one month in advance of their preferred Art Walk.
- To participate in the 3rd Saturday Art Walk in Roseville.
- To work with the Art Walk Coordinator and arrange for a mutually convenient time for hanging and removing the works.
- To hang and display up to ten pieces of original art.
- To have your exhibited work on display during regular business hours for the time period agreed upon between you and the venue. Artists are encouraged to attend the 3rd Saturday date at the assigned venue from 5pm-8pm
- To handle the sale of artwork after the venue has supplied the contact information of interested parties to you. Any sold artworks will remain installed for the entirety of the exhibition period unless agreed upon otherwise with the venue.
- That any agreed commission to the venue will not exceed 15% and will be agreed upon in advance between the business owner and the artist.
- Organization and delivery, with the assistance of the Art Walk Coordinator, of an Artist Statement/Biography and labels that include the following information: TITLE OF WORK, MEDIUM, PRICE, ARTISTS NAME
- Provide complete list of artworks on exhibition to the Art Walk Coordinator upon installation of work at the venue.

Services to be Provided

- Facilitation (by BLA) of the Call to Artists to bring local artists to exhibit original pieces or prints that will be installed by the artist with the assistance of the Art Walk Coordinator in a timely manner. BLA will work with the business owner to match the artist with the venue.
- BLA updates online map widget monthly with current venue and artist information as well as local event calendars, social media updates, and recognition on BLA website.
- Artist assumes all risk of loss, damage or destruction of his/her work. Artists are welcome to get their work insured.
- Artist receives an Art Walk Poster and magnets for distribution.
